Sienna Private Credit closed a €47 million financing for LOCAMOD alongside Santander AM





Paris, 15 February 2022. Sienna Private Credit (formerly Acofi Gestion) is pleased to announce the closing of a €47 million private bond issuance transaction, equally shared with Santander AM, for LOCAMOD. This transaction is intended to refinance a debt taken out with JP Morgan during the last LBO.

Founded in 1982 in Alsace, the group is one of the multi-regional players specializing in the rental of construction equipment, lifting equipment, modules and scaffolding in France aiming to become the third largest multi-specialist rental company in France. The rental player is also a responsible company engaged in reducing its environmental impact.

Sienna's 8-year instrument offers an interest rate reduction in return for the achievement of annual social objectives, namely gender parity and the inclusion of seniors over 55 years-old.

The bond is one of the first joint-investments for the Predirec ABL-3 fund (classified as SFDR article 8) and a fund classified as SFDR article 9, which are currently in the process of raising funds, and are beginning to deploy financing for European SMEs/SMIs backed by their tangible assets (machinery, inventory, real estate) with a sustainable impact approach based on incentive clauses.

Laurence Choisy Lemesle, manager of the Predirec ABL-2 fund, shared: "We are pleased with the completion of this new transaction, which has enabled LOCAMOD to reorganise its long-term financing thanks to an AssetCo model which provides a solid base to support the group's ambitions going forward."
